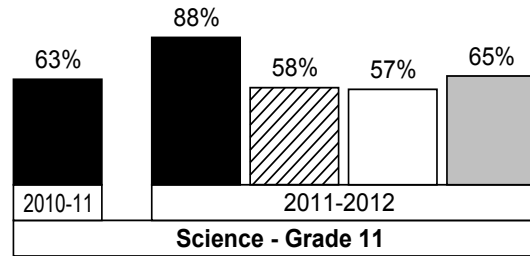
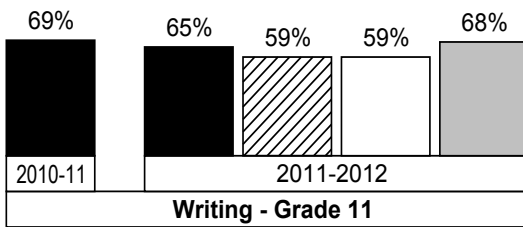
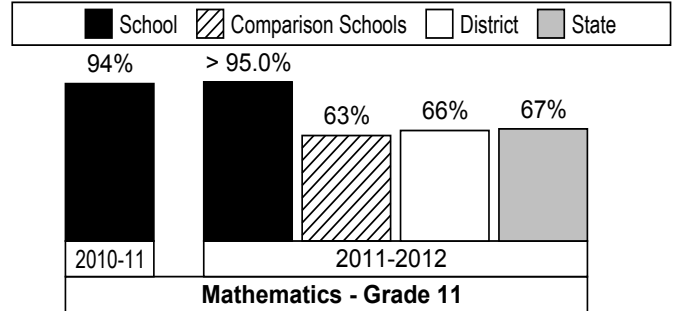
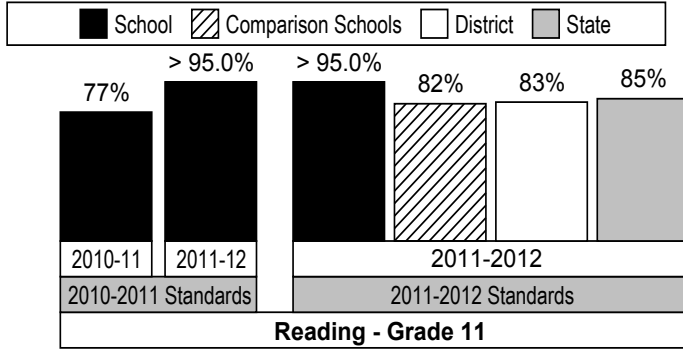

## Academic Achievement Percentage of Students Meeting Standards
